In order to ensure that you, our valued guests, experience the cruise of a lifetime, we here at Norwegian Cruise Line ask that you familiarize yourself with the following important guidelines during your stay on the beautiful M/S Norwegian Star.

<p style="text-align: center;">VERY IMPORTANT NOTICE</p> <p>Please be advised that any type of abuse towards NCL staff or property falls under Federal Law: similar as on any aircraft and will be dealt accordingly. You must carry your NCL key card and a picture ID when going ashore. Due to high level of security, shore side security engaged in searching persons returning to the ship, have been instructed to confiscate and retain any kind of knives and any items which may be considered a potential danger or can be used as weapon.</p>	<p style="text-align: center;">USE OF PERSONAL IRONS</p> <p>U.S. Coast Guard does not recommend use of personal irons & open candles on board the cruise ships. However, use of personal irons is your own risk. Guest will be held liable for damaged ship's property.</p> <p>Please do not tape any signs or posters on your stateroom door as it will damage the door paint. In order to keep the ship's architecture in tact we may remove the items posted on stateroom doors.</p>
<p style="text-align: center;">PERSONAL SAFETY</p> <p>All sports activities are at your own risk. Always wear proper footwear for sporting events and always use caution. Decks are slippery when wet. Beware of heavy doors and hold on to hand rails at all times.</p>	<p style="text-align: center;">BARONG SPA CANCELLATION POLICY</p> <p>We hope you do not have to cancel. Cancellations made with less than 24 hours notice will be subject to full charge.</p> <p style="text-align: center;">PHONE CHARGES</p> <p>There will be \$5.95 charge per minute for all the calls made from the ship including 800 numbers & calling cards.</p>
<p style="text-align: center;">MEDICAL NOTES</p> <p>If you use needles for injections, please pick up a container for discarded needles from the Medical Center at no charge. For the safety of our guests and crew <u>please do not dispose</u> of needles in the regular waste bin. Also there are associated risks with consuming raw oysters or animal protein, especially if you have a chronic illness or immune disorder. If you are unsure, please consult a physician.</p>	<p style="text-align: center;">SMOKING POLICY</p> <p>We kindly ask you to please observe the designated smoking areas. Starboard side is smoking in designated areas. Port side is non-smoking. The Stardust Theatre, all restaurants and elevators are smoke free environments. Please refrain from walking with or throwing cigarettes overboard as this may cause a fire. Cigar and pipe smoking is not permitted inside the vessel except in the Cigar room.</p>
<p style="text-align: center;">VACUUM TOILET SYSTEM</p> <p>On board the M/S Norwegian Star, vacuum toilets are technically the best system for water conservation and protection of the environment. They are very efficient but also vulnerable at times. Please note that the vacuum system will not function if you flush any of the following: Paper towels, clothes, small metal, plastic, sanitary napkins, tampons, diapers, and thick facial tissues. If one toilet is blocked, at least 50 more toilets will stop working and create a major inconvenience to other guests.</p>	<p style="text-align: center;">ALCOHOL POLICY</p> <p>Liquor purchased ashore in any Port of Call will be collected by the security at the Gangway upon boarding the vessel and will be returned to you at the end of your cruise. Strictly Enforced: Service and consumption of alcoholic beverages requires the minimum age of 21.</p> <p style="text-align: center;">WHEEL CHAIR SERVICE</p> <p>We provide wheel chairs to our guests for on board use only with the available wheel chairs. We do not provide wheel chairs out side of the vessel.</p>
<p style="text-align: center;">PROTECT OUR OCEANS</p> <p>NCL recycles the ship's refuse with the latest technology to help save our environment. Please be aware of the ecological balance that must be maintained. In order to accomplish this, we ask all of our guests to play their part by not throwing any debris overboard in the ports or while the ship is at sea. Please use the proper receptacles throughout the ship to dispose of garbage. Please be aware of the high chlorine level in the Swimming pools and the Jacuzzis required by U.S. Public Health.</p>	<p style="text-align: center;">CHILD CARE</p> <p>For the safety of your children, the following rules have been established. We kindly ask for your assistance in enforcing them. A parent's supervision is required for the use of elevators, public rooms, lounges, whirlpools, water slides and the fitness center. There are NO life guards on duty at the swimming pools and hot tubs. Also, sanitation regulations bar children in diapers or who are not toilet-trained from entering swimming pools.</p>
